## Nominations Committee Update and Future Plans - report for TB and Council

Summary of Tasks completed since the last report dated 11 May 2022

## 1. Strategy Committee - International Young Member vacancy - on-going task

The Strategy Committee would like an International Young Member to join the committee. The advertisement for this position is now live on the website here. The closing date to submit applications is by 17:00hrs BST on 8 August 2022.

## 2. 2022 Corporate Election process - casual vacancies - on-going

NomCo's role in this process has been detailed in the newly approved TB regulations. The Nominations Committee wishes to adhere to its previously stated approach of appointing new faces, particularly with regard to casual vacancies, from as wide a talent pool as is possible.

### 2.1 Trustee Board - casual vacancy for an International Ordinary Member on the Trustee Board - task complete

This was advertised to all members online in May 2022. There were 13 applicants and the NomCo "Lite" Process was applied to score and rank all the applicants. A shortlist of 3 candidates were identified for interview using the consolidated scores process. The interviews were all held on 20 June 2022 and the successful candidate is Professor Graeme Britton.

All 4 have progressed to the next stage of induction to join the 24 other individuals already appointed.

## 4. Audit \& Risk (ARC) - $\mathbf{2}$ vacancies - completed task

This was advertised to all members online in March 2022. Candidates from previous NomCo selections were also identified as being suitable for ARC and they were made aware of the vacancies.

There were 21 applicants and the NomCo "Lite" Process was applied to score and rank all the applicants. A shortlist of 7 candidates were identified for interview using the consolidated scores process. The interview panel has representatives from ARC together with members of NomCo.

The interviews are now complete and Elizabeth Tarr and Graham Hughes have been appointed to Audit and Risk.
